

Cell Phones:

Cell phone usage is a privilege at Glen Ullin Public School. Students may use them prior to the school day, during noon hour, **in between classes**, and after school. Otherwise, cell phones must be turned off while in the building and put away.

Cell phones are not to be **used (Cell phones can be used)** in the school lunch room during breakfast and lunch. The school district will not be responsible for lost or stolen cell phones. Staff will take appropriate actions if a cell phone is seen or heard during the school day. Disciplinary actions include, but are not limited to:

1st offense: Cell phone will remain in the office until the end of the day, the student will be allowed to pick up the phone.

2nd offense: Cell phone will be kept in the office for 2 days, the parent/guardian must pick up the phone.

3rd offense: Cell phone will be kept for one (1) week, the parent/guardian must pick up the phone.

4th offense: Cell phone will remain in the office. A conference will be held with the parent/guardian, student and administrator.

Electronic Devices:

Any devices such as iPods, walkmans, disc players, etc. may be used in the hallways and in the classrooms with permission from the teacher. Otherwise, they should be stored in lockers.

Laser pointers are not allowed by students at any time.

Any electronic device may be confiscated if it becomes a disruption of any sort.

Dress Code:

The staff assumes that the students will use good judgment in wearing appropriate clothing for school and all school events. Personal appearance is usually an index to the attitude and behavior patterns of an individual. It is the responsibility of the parents to see that their children are neat, clean and appropriately dressed as to the activity involved and respective age levels of students. Our dress code encourages students to use good taste and common sense. Students found to be dressed in attire that creates a danger to health or safety; creates a disruption to the educational process; violates common standards of decency; or has inappropriate slogans or words will be dealt with at the discretion of the administration.

1. Students should dress modestly and should not reveal their undergarments, midriff or cleavage.
2. No holey jeans above mid thigh.
3. Bottoms, including but not limited to pants, shorts and skirts, must be worn at, or moderately below the natural waistline.
4. The hem of the student's top must cover the waistband of the student's bottoms with absolutely no skin or underwear exposed.
5. **The hem of shorts or skirts must be at or below mid-thigh.**
6. Clothing shall not display, suggest or advertise drugs, tobacco, alcohol, obscene language, or items of sexual nature.

7. Caps, hats, hoods, bandanas and head apparel will not be worn in the building except on designated days. Common courtesy dictates the removal of caps and hats upon entering the building as a sign of respect.
8. Chains of any kind and spiked jewelry are not allowed due to safety issues.
9. No flannel bottoms, pajama-looking bottoms, or sweat pants except on designated days.
10. Jackets and coats will not be allowed in the classrooms.
11. Sunglasses may not be worn in the building without written doctor approval or designated days.
12. Individual classroom rules may apply for classes that incorporate labs.

Eligibility Policy:

- A. The use or possession of tobacco, alcohol, or any controlled substance is prohibited as defined by North Dakota law and/or policies established in this Student/Parent Handbook. Any participant who is in violation of North Dakota High School Activity laws and/or Glen Ullin/Hebron Public School Policies will be suspended from performance as established. First violation—6 week suspension. second violation—18 weeks, further violations will result in suspension from the team.
- B. Academic Policy A student can only be failing or have an incomplete in one (1) class to maintain eligibility for athletic performances. (Would like to change the policy to “A student cannot be failing any classes to maintain eligibility for athletic performance.”) Eligibility is determined each week on Monday a.m. A student who is ineligible will not be permitted to participate in athletic contests but must practice with the team during that week. Ineligible students in grades 7-12 will not sit or travel with the team. IMPORTANT NOTE: It will be the school’s responsibility to inform his/her parents of ineligibility to participate in contests.

The North Dakota High School Activities Association requires that a student must be passing a minimum of 4 full-credit classes or its equivalence (at least 20 class hours per week) each semester. Failure to adhere to this Activity Association policy will make the student ineligible for a period of four (4) weeks the following semester.
